System of competition:	<b>system of groups (league)</b> is applied for pattern and sparring. In order to number of competitors, the group can be split. <b>Sparring is for blue belts and higher only.</b> <b>Point fight is for green belts (6<sup>th</sup> &amp; 5<sup>th</sup> kup) only.</b>

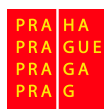

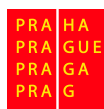

in groups: match 1 x 2 min. (younger & older youth 1 x 1,5 min.)

in case of two competitors in category: match 2 x 2 min. (younger/older youth  
male/female 2 x 1,5 min.)

**Length of round is mentioned on „clear“ time.**

- Sparring is for blue belts and higher only. Compulsory spinning kicks are not required.
- **Point fight is dedicated to holders of 6<sup>th</sup> & 5<sup>th</sup> kup (green belts) only).** Compulsory protective equipment is same as sparring. Points:
  - Hand technique to middle or high section = 1 point
  - Kick to middle section = 2 points
  - Kick to high section = 3 points
  - Warnings and minus points same as in sparring
  - Compulsory spinning kicks are not required.



**IV. Rules:** ITF rules and this info pack implied. Only [approved protected gear](#) can be used.

Teeth protection as well as helmet is mandatory to all. Gloves with open palms are mandatory to youth age division, 10oz gloves to Juniors.

**The colour of the protectors is required according to the side on which the competitor enters.**

The Year of birth determines competitor's age division, not the date of birth!

In case of low number competitors in a category, the categories can be merged or the length of the round can be shorten.

**V. Number of competitors:** There is no limit for number of competitors per category.

**VI. Protest:** Protest must be filled according to ITF rules in 5 minutes since the end of the round with **500 CZK** deposit.

**VII. Umpires:** Each club provides with  
**1 umpire in case 10 or less competitors**  
**2 umpires in case of 11-20 competitors**  
**3 umpires in case of more than 21 competitors.**

Umpires may also compete but the club must provide with required number of umpires for whole day. **1000 CZK fee per each missing umpire.** Umpires are required wear proper clothing by ITF rules.

We provide with lunch for free as well as pocket money for each umpire.

**VIII. Trophies:**

Winner is awarded with golden, silver or bronze medal. Best individuals as well as three the most successful clubs are awarded with trophy. In addition, best individuals are to receive **Hayashi voucher as well as Ataxon gear.**

**IX. Others:**

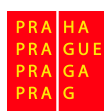
Based on the Czech legislation, competitor must be medically fit when taking part in sports tournaments. All potential risks during the tournament is borne by the competitor. No doping is allowed during the tournament; all competitors are to undertake doping tests when required.

**X. Accommodation & food:**

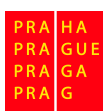
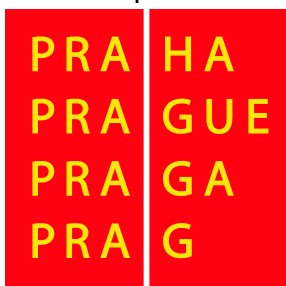
